



1. We hereby declare that the papers used for the production of the corrugated packaging produced by Smurfit Kappa Northampton Corrugated plant complies with purity, organoleptic inertness and no transfer of antimicrobial product specifications as laid down in the following regulations:

— **Regulation 1935/2004** of Council and European Parliament on 27-10-2004.

— **Resolution AP (2002)1** : Paper and Board - Material and articles intended to come into contact with foodstuff.

— **German recommendation BfR XXXVI** on papers and boards intended to come into contact with foodstuffs ("Deutschen Empfehlung XXXVI zur gesundheitlichen Beurteilung von Kunststoffen im Rahmen des Lebensmittel- und Bedarfsgegenständegesetzes, 34. papers and boards and converted paper and board articles intended for food contact use ("Guide de Bonnes Pratiques pour la fabrication des papiers et cartons et des articles transformés en papier et carton destinés au contact des denrées alimentaires" BPF) and completed by the Information Note n° 2004-64 of a department (DGCCRF) of the French ministry for Economy, Finance and Industry.

2. We declare that Smurfit Kappa Northampton Corrugated plant has implemented a management system for the safety of packaging intended to be in contact with foodstuff (BRC/IOP), in compliance with the requirements of Regulation 1935/2004/EC and Resolution AP(2002)1 both relating to material and objects intended to come into contact with foodstuffs. The site is certified to BRC/IOP food contact standard by the Royal Society for the Promotion of Health. The most recent audit is available on request.

This allows us to state that the corrugated fibreboard produced by Smurfit Kappa Northampton complies with the framework regulation 1935/2004/EC and can be used safely for food packaging. Corrugated fibreboard manufactured by Smurfit Kappa Northampton can be used in direct contact with type Type II & III foodstuff (dry, non fatty foodstuff).
